Section 48E Credits:

40% CREDIT

Armstrong's use of domestic content in the production of Templok Ceiling Systems, in addition to you meeting prevailing wage and apprenticeship requirements may qualify for a tax credit of 40%.

When Templok Ceiling Systems are deployed in an "Energy Community," an additional 10% tax credit may be available.

Inflation Reduction Act of 2022

Section 48E Tax Credit



Under section 48E, the purchase and use of Armstrong Templok Energy Saving Ceiling Systems containing thermal energy storage properties (phase change material), including suspension, may qualify for a federal investment **tax credit of up to 50%** of the project purchase cost.

What type of projects qualify?

Owners of qualified commercial buildings and designers of EECBP/EEBRP installed in buildings owned by specified tax-exempt entities will qualify. Templok Energy Saving Ceilings may qualify as part of a building's heating, cooling or ventilation systems.


